The following images will not be allowed for Cargills Bank Image card:

- Trademarks or copyright material that is famous or recognized, including images marked with ©, ® or ™ signs.
- Images that have advertising, promotional material including branded products and services.
- Images that have telephone numbers, URLs, account numbers or email addresses.
- Images of celebrities/musicians/athletes/entertainers/public-figures/cartoon characters etc. that are famous or recognized.
- Provocative or sexual images including inappropriate nudity or semi-nudity.
- Violent or offensive racist images including any images in which weapons or fire arms are shown.
- Images portraying anti-social or obscene behaviour.
- Images where drinking(or being drunk), smoking, narcotics or gambling are the focus, or if drinkers or smokers look under-age.
- Any religious or political images, including images that portray socially unacceptable groups or political statements.
- Images where money or currency is focus.
- Trade names, logos, slogans or other identifying of any Card Processing Associations (e.g. Visa, Master Card, American Express, etc.).
